# SUMMARY OF THE SUPREME COUNCIL'S ACTIVITIES

During 2024, Members of the Supreme Council held seven meetings of the 33° at which thirteen candidates were promoted, conducted eleven meetings of the Higher Degrees (during which 516 Brethren were invested), installed thirteen Inspectors General, re-presented patents to thirteen Inspectors General and visited the Districts of Bedfordshire & Hertfordshire, Berkshire, Cumberland & Westmorland, Dorset, Dyfed, North Essex, Gloucestershire & Herefordshire, Hampshire & Isle of Wight Solent, Hampshire & Isle of Wight Wessex, West Kent, South East Lancashire, South West Lancashire, Leicestershire & Rutland, Lincolnshire, Norfolk, Northamptonshire & Huntingdonshire, Northumberland, Somerset, Staffordshire & Shropshire, Warwickshire, Worcestershire, Yorkshire, North & East Ridings, the St James, St Matthew and St Peter Groups of London Chapters and Bahamas & Turks, Jamaica & the Cayman Islands, South Africa Eastern Natal, South Africa Western Cape and South Eastern Caribbean. Higher Degrees Meetings were also held in Bahamas & Turks, Ghana, Nigeria and South Africa. Six visits to foreign jurisdictions were conducted, to the Supreme Councils for Canada, Cyprus, Estonia and Scotland and the Icelandic and Norwegian Orders of Freemasons. # **MEMBERSHIP STATISTICS**

966 candidates were Perfected in the year to 30th June 2024 compared with 909 in the previous year. The number of subscriptions received fell by 560 to 21,766. The number of extant Chapters on 30th June 2024 was 877 with an average membership of 25. The average age of candidates for Perfection was 53.

# ANNUAL DUES, FEES AND LEVY

The Supreme Council has decided that the Annual Dues payable on 1st July 2025 will rise to £25.00 (plus VAT where applicable) for every subscribing member of each Chapter during all or part of the preceding year. Dues have remained static since 2017, since when there has been a 42% increase in inflation, and members will appreciate the need to take this into account. Members should also note that the increased dues are still below that of all other masonic Orders. Much smaller but more frequent increases are planned for the future. Districts overseas (except where special arrangements apply) will now remit £21.00 per subscribing member, retaining the balance of £4.00 to help defray District costs. The maximum levy that each Inspector General is authorised to make on each subscribing member in his District/Group to help defray District/Group costs remains at £2.00.

#### CHAPTER TREASURERS

All Chapters are asked to give careful consideration to the consequences that may arise should their Treasurer become indisposed. In particular, Chapters should avoid having only one signatory on their bank accounts and should ensure that a second responsible person has access to the online banking details.

# RELATIONS WITH OTHER JURISDICTIONS

The Supreme Council is currently in amity with the following jurisdictions:

- a) The Supreme Councils for the United States of America (the Southern Jurisdiction and the Northern Masonic Jurisdiction), Andorra, Argentina, Australia, Austria, Belgium, Bolivia, Brazil, Canada, Côte d'Ivoire, Croatia, Cuba, Cyprus, Czech Republic, Estonia, Finland, France, Germany, Haiti, India, Ireland, Israel, Latvia, Lithuania, Luxembourg, Mauritius, the Netherlands, New Zealand, Panama, Philippines, Poland, Portugal, Romania, Russia, Scotland, Serbia, Slovakia, Slovenia, Spain, South Africa, Switzerland, Togo, Turkey, Ukraine, Uruguay and Venezuela; and
- b) The Danish, Icelandic, Norwegian and Swedish Orders of Freemasons. (new relations in **bold**)

Please note that no Supreme Council in Greece is currently recognised as regular by this Supreme Council.

If you intend to visit a Chapter of a jurisdiction with which we are in amity, other than Scotland or Ireland, please obtain your Inspector General's approval in advance. This is particularly important in the case of territories, such as Brazil, Cyprus and France, in which there are several Supreme Councils of which only one is considered regular. The same applies if you wish to invite a member of another jurisdiction to visit your Chapter. If you wish to visit a Chapter under the Supreme Council for Ireland, you must contact the office of the Grand Secretary General beforehand.

Communications between Supreme Councils are normally conducted by Grand Secretaries General. Brethren should therefore not attempt, without the Grand Secretary General's prior permission, to make direct contact with another jurisdiction.

#### **DUAL ALLEGIANCE/AFFILIATION**

Brethren are reminded that except in New Zealand and India, where specific arrangements are in force, allegiance to more than one Supreme Council is not permitted. Enquiries about this subject are to be submitted to the Grand Secretary General.

#### THE 2024 RITUAL AND 2025 YEAR BOOK

You are reminded that all Chapters are now strictly enjoined to use the 2024 18° and Enthronement rituals.

The Supreme Council requires that a copy of the Year Book be given to every new member on his Perfection. The Year Book provides detailed lists of Districts, Groups and Chapters. It also contains an Historical Section, with chronological lists of Members of the Supreme Council (and the offices they have held), of the South African Branch Council and of other members of the  $33^{\circ}$ . A copy of the Year Book, the cost of which is £12, is sent to each Chapter Recorder. You may order copies of the 2025 Year Book through your Recorder or purchase one in person from Reception at 10 Duke Street St James's.
